 - a. Started ~5 years ago
 - b. Some key parties involved
 - i. Building committee comprised of administration and President who have final say in decisions
 - ii. MITIMCO Investment Management group that gets funds from endowment, is not responsible to MIT faculty
 - iii. PCRSP/RCSRP Planning & Renovation (what classrooms get renovated, etc.)
 - c. There is no faculty Senate
 - d. One community, one campus (2016) is closest thing to a strategic plan info about this was sent to faculty in an email (they were not consulted beforehand)
 - e. Who deals with communications? MIT Community Affairs office
 - f. There could be more graduate student and postdoc representation in the committee similar to libraries committee which added more student members

- 3. Site 4 Rates and Discussion (6:45 7:15 PM)
 - a. There is a petition written about Site 4 link to petition
 - b. Current Eastgate resident get 15% off the listed price of units for duration of stay and additional transition packages (after financial process) to ease transition
 - c. Such financial processes can be unpleasant or even humiliating, something to be aware about
 - d. Communication on the developments on extra support has been quiet Westgate residents have heard things through the grapevine but not sure what's right (things feel hushed)
 - e. Some families (Sloan folks with many savings) may not need subsidies so the strategy from Housing might make sense
 - f. International families would struggle but will probably get the support they need to move into Site 4
 - g. There should be a long term plan to provide support for those who need it
 the current support mechanisms seem very reactionary and just meant to
 appease upset students
 - h. People who made these decisions are no longer in power now everyone pays for it
 - i. Improved communication is one long term goal
 - j. What happens to incoming students who can't afford to live here but can't find Housing in Westgate? Incoming international families may struggle
 - k. A more actionable item (compared to the points in the petition) are to identify pain points of the financial process and fix them.
 - I. The financial form is a Google form which can be convoluted for many families to read through/understand.

 - n. There is a family grant for support, but only offer ~\$2k
