A Bylaws Amendment To Modify the Housing Representatives for Future Dorms

Whereas, the Massachusetts Institute of Technology (MIT) Graduate Student Council (GSC) maintains one representative from all active on-campus graduate residence halls;

Whereas, the GSC bylaws currently list all living groups with representation;

Whereas, Eastgate is no longer an active residence hall;

Whereas, 70 Amherst and Site 4 are new active residence halls; and

Whereas, Article III, Section B of the GSC bylaws currently reads:

Each of the following on-campus graduate living groups shall have one representative: Ashdown House, Eastgate, Edgerton House, NW30 (also known as The Warehouse), Sidney-Pacific, Tang Hall, and Westgate.

Whereas, to account for future residence hall representation without a GSC bylaws amendment; now, therefore, be it

Resolved, Article III, Section B of the GSC bylaws are hereby amended:

Each active on-campus graduate residence hall housing more than 10 graduate students shall have one representative.

Article III, Section B:

Each **of the following active** on-campus graduate **residence hall living groups housing more than 10 graduate students** shall have one representative. ~~.: Ashdown House, Eastgate, Edgerton House, NW30 (also known as The Warehouse), Sidney-Pacific, Tang Hall, and Westgate.~~
